AMENDMENT #41 (Minor Amendment): A sum of \$147,000 is being reallocated from the Public Infrastructure Improvements Continued Activity to the Consultant Administrative Cost Activity, the City of Joplin Administrative Cost Activity, and the 20th and Main Street Improvements Activity. The funds being reallocated to the Consultant Administrative Activity and the City of Joplin Administrative Activity will be used to cover grant administrative costs. The funds being reallocated to the 20th and Main Street Improvements Activity will be used for the project's final activity delivery costs. (Please see the attached revised budget).
